Clara Altman, Visiting Assistant Professor of Law, Jurisprudence and Social Thought, received a B.A. in history and political science from Washington University in St. Louis and a J.D. from Brooklyn Law School, and she is a Ph.D. candidate in American History at Brandeis University. Her research and teaching focus on U.S. legal history in transnational, international, and imperial perspectives.

Bradley Bailey, E. Rhodes and Leona B. Carpenter Postdoctoral Curatorial and Teaching Fellow in Japanese Prints at the Mead Art Museum, received a B.A., M.A., and M.Phil. in the history of art from Yale University, where he is also a Ph.D. candidate. In addition, he holds an M.B.A. from the Yale School of Management. He studies Japanese art from 1700 to the present, with special emphasis on its influence on Western art and art markets. He is also interested in museum management and art finance, having worked at the Yale University Art Gallery and the Solomon R. Guggenheim Foundation.

Brian Baisa, Assistant Professor of Economics, received a B.S. from the University of Michigan and a Ph.D. from Yale University. His research is on game theory, with a focus on auction design. Her work is noted for its unique approach to staging classic and contemporary plays, opera, performance art, dance and installation and has been presented in America, Mexico, the Netherlands, Germany, India, the West Indies, and Croatia.

Ashley Brown Burns, Robert E. Keiter '57 Postdoctoral Fellow and Visiting Assistant Professor of Political Science, received her B.A. in political economy from Williams College and her M.A. and Ph.D. in public policy from Duke University. Her current work examines intersections of social problems and political action, particularly stratification and contemporary American public policy.

Kalisha Cornett, Five College Fellow in English and Film and Media Studies, graduated from the University of Colorado-Boulder with a B.A. in English and a B.S. in journalism. She is now enrolled in the Cinema and Media Studies Graduate Program at the University of Chicago and is completing a dissertation titled "Out of the Blur of the background: Landscape as medium in post-classical American cinema."
